ALPENA PUBLIC SCHOOLS BONDING PROPOSAL

Shall Alpena Public Schools, Alpena and Presque Isle Counties, Michigan, borrow the sum of not to exceed Thirty-Three Million Nine Hundred Thousand Dollars (\$33,900,000) and issue its general obligation unlimited tax bonds therefor, in one or more series, for the purpose of:

partially remodeling, furnishing and refurnishing, and equipping and re-equipping school facilities, in part for secure entries and other security purposes; erecting, furnishing and equipping secure entry additions to school facilities; and developing and improving sites?

The following is for informational purposes only:

The estimated millage that will be levied for the proposed bonds in 2020, under current law, is 0.67 mill (\$0.67 on each \$1,000 of taxable valuation), for a -0- mill net increase over the prior year's levy. The maximum number of years the bonds of any series may be outstanding, exclusive of any refunding, is twenty-five (25) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 1.42 mills (\$1.42 on each \$1,000 of taxable valuation).

The school district does not expect to borrow from the State to pay debt service on the bonds. The total amount of qualified bonds currently outstanding is \$4,365,000. The total amount of qualified loans currently outstanding is \$-0-. The estimated computed millage rate may change based on changes in certain circumstances.

HILLMAN COMMUNITY SCHOOLS OPERATING MILLAGE RENEWAL PROPOSAL

This proposal will allow the school district to continue to levy the statutory rate of not to exceed 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its full revenue per pupil foundation allowance and renews millage that will expire with the 2020 tax levy.

Shall the currently authorized millage rate limitation of 18.48 mills (\$18.48 on each \$1,000 of taxable valuation) on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Hillman Community Schools, Montmorency, Alpena and Presque Isle Counties, Michigan, be renewed for a period of 4 years, 2021 to 2024, inclusive, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and 18 mills are levied in 2021 is approximately \$1,838,616 (this is a renewal of millage that will expire with the 2020 tax levy)

Fire Department Operation Millage Renewal Proposal

Shall the Rogers City Area Fire Department Authority levy an ad valorem tax of not more than one mill (\$1.00 of each \$1000 of taxable value) against all taxable property within the limits of the Rogers City Area Fire Department Authority for the purpose of funding the operation of and capital equipment, facilities and improvements for the Rogers City Area Fire Department Authority and its provision of fire protection and other emergency health and safety services as authorized by Section 12 of Act 57 of the Public Acts of 1988, as amended, being MCL 124.612 and shall the Authority levy such millage for said purpose for the years 2021 through 2036, inclusive (a sixteen year period beginning with the tax levy on the 12/01/2021 and ending with the tax levy on 12/01/2036)?

It is estimated that one mil would generate revenue in the amount of \$198,645.00 in the first year. The proposed millage is a renewal of a previously authorized millage. The previously authorized millage will expire with the 12/01/2020 tax levy.

Note: If approved and levied, in accordance with State Law, a portion of the renewal from this millage collected on certain properties lying within the established Downtown Development District of the City of Rogers City will be captured by or disbursed to the Rogers City Downtown Development Authority for authorized purposes. The amount of such capture is estimated to be \$971.69 in the first year of the levy.
