MCSSA District II Meeting Update:

Extensive discussion about the meeting on Thursday, January 25, 2024 as Chris, Cynthia, and Julie were all in attendance.

Don Bartosch has stepped down as president. Attendance was poor and there was not a quorum so voting did not happen. No one present at the meeting was interested in filling one of the board vacancies. Alpena County Director, Tina Smigelski, agreed to talk with the current vice president, who was out of town, to see if she would agree to become the president.

Times and dates of the meeting have been altered to try to accommodate participant schedules. Julie suggested that some boards chose to meet in the evening to allow working individuals to attend, but not sure if that will help in this situation as some current attendees may then chose to not attend in the evening.

Board members find this situation with MCSSA District II to be quite discouraging and not sure how and if the situation can be improved. The next meeting is scheduled for Thursday, April 25, 2024 at 10:00 am in Gaylord.

MCSSA Vice President/Legislative Committee/Development and Education Committee Updates:

Allan was absent today so there were no updates available.

MCSSA Legislative Conference and Registration Packet:

Julie provided the MCSSA Legislative Conference Registration Packet for April 9th and 10th. Chris and Cynthia both indicated their interest in participating this year. They plan to coordinate with one another and will present their registration packets to Ann Marie Main by February 23rd to give Ann Marie time to process their registrations and payment.

Agency Update:

Medicaid Redetermination information not available for this meeting.

Julie shared the Staffing Allocation and explained reasons for red-lining of 1 NFIS worker and what that means for her, as well as coverage for the FIM position with a 2nd Line Program Manager position, loss of 1 CPS vacancy, gain of 1 FC position, gain of 1 JJ position, gain of 1 ES position. In addition, a 2nd CPS vacancy was taken to cover another county's unfunded position. Once all allocation packages are approved, Julie will learn whether there are any transfers to her county and then will be able to post for vacancies for remaining positions that are not filled with transfers.

Although staffing shortages in child welfare have been problematic throughout the state, Wayne County is in a dangerous situation. Since they are so extremely short staffed, they are unable to ensure child safety. Request has been made statewide for CPS staff to volunteer to go to Wayne County to work for an extended period of time and/or for other CPS workers to work from their home county as the primary worker. Face to face interviews, home visits, well-child verifications will take place by a Wayne County courtesy worker with out-stationed primary workers participating virtually. Court hearing participation may also take place virtually by the out-stationed primary worker unless the judge or attorneys require in-person presence.

Cheboygan-Presque Isle workers are concerned with their liability servicing Wayne County cases, but may likely be required to take on cases from our surrounding counties who's workers have volunteered to handle Wayne County cases.

Round Table:

Chris is a member of the Optimist Club and shared struggles their Club is having in working with Roger City Elementary School for food distribution to 24 students at the Elementary School, 2 students at the Catholic School, and 1 at the Lutheran School. The school initially requested assistance with food distribution through the backpack program. They no longer reference the food distribution as the backpack program but they deliver 4 weeks of food 1X per month to the school for distribution. The Optimist Club members cannot know who the students are and the school is no longer wanting to distribute the food. They want the Club to use another location, however, again the Club members

cannot have contact with the families. Chris feels the school is not wanting to take responsibility for ending the food distribution program, but rather wants the Optimist Club to pull out. The Optimist Club would like to see this assistance continued to students and their families. This issue is now being taken to the school board for resolution.
