To The Qualified Electors in the county of Presque Isle, State Of Michigan

PLEASE TAKE NOTICE that any qualified elector of the Presque Isle County Townships and Cities; who are not already registered, may register to vote at the office of the Township or City Clerk; the Office of the appropriate County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at www.mi.gov/vote and mailed to the Township or City Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **Monday, July 20, 2026**. After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the following:
